The digital **Dataroom** product is ideal for legal and/or financial organisations carrying out due diligence on the sale of a company. CTC's first Dataroom product was used in this way to help ReOrient Legal Ltd manage the sale of Hastings Direct, the UK's 5th largest insurance broker, a transaction that was carried out largely online through the use of this innovative technology.

The system incorporates the highest levels of security with only authorised personnel being able to access the system (via unique pincode, username and password).

All data is encrypted before being stored, and protected by 256-bit SSL (Secure Socket Layer) encryption during transfer to and from the website.

A full audit trail of documents viewed/downloaded is made available on a person by person basis.

The system also offers an **Information Request Centre** that allows interested parties to liaise with the project management team, make requests for information and see fully documented replies to their requests, without the need to send this information through unsecured methods such as email.

CTC's Virtual Dataroom Solution has multiple security features controlling access to the information stored in the data room:

- Initial access to the data room is by unique pincode, user name and password.
- All documents stored within the data room are encrypted using military standard algorythms users can be assured that the data has not been modified in any way.
- Access to documents is controlled by permissionbased rules - if a user isn't intended to see a document, he/she will not know it exists.
- Members of different Groups will not be aware of other Groups in the system (unless they are also members of those groups).
- The virtual dataroom website is protected by 256-bit SSL encryption, protecting all data during transfer.
- A full audit trail of documents viewed or downloaded is provided. You can see who has downloaded which documents and when.
- Users of the Dataroom are required to sign your "Terms and Conditions of Dataroom Use" and "Confidentiality Agreement" before being given access to the Dataroom.
- All data is backed up to a separate offsite server location.
