Document Vault Systems' M&A Virtual Data Room product is a secure document management system which enables organisations to upload document libraries which can be accessed via a website from anywhere in the world.

The digital **Data Room** product is ideal for legal and/or financial organisations carrying out due diligence on the sale of a company. Document Vault's first Data Room product was used in this way to help ReOrient Legal Ltd manage the sale of Hastings Direct, the UK's 5th largest insurance broker, a transaction that was carried out largely online through the use of this innovative technology.

The system incorporates the highest levels of security with only authorised personnel being able to access the system.

All data is encrypted before being stored, and protected by 256-bit SSL (Secure Socket Layer) encryption during transfer to and from the website.

A full audit trail of documents viewed/downloaded is made available on a person by person basis.

The system also offers an Information Request Centre which allows interested parties to liaise with the project management team, make requests for information and see fully documented replies to their requests, without the need to send this information through unsecured methods such as email.

#### Security

Document Vault has multiple security features controlling access to the information stored in the data room:

- Initial access to the data room is by unique pincode, user name and password.
- All documents stored within the data room are encrypted using military standard algorithms users can be assured that the data has not been modified in any way.
- Access to documents is controlled by permissionbased rules - if a user isn't intended to see a document, he/she will not know it exists.
- Members of different Groups will not be aware of other Groups in the system (unless they are also members of those groups).
- The virtual data room website is protected by 256bit TLS/SSL encryption, protecting all data during transfer.
- A full audit trail of documents viewed or downloaded is provided. You can see who has downloaded which documents and when.
- Users of the Data Room are required to sign your "Terms and Conditions of Data Room Use" and "Confidentiality Agreement" before being given access to the Data Room.
- All data is backed up to a separate offsite server location.
